Peter Tumilty, Senior Executive Director of Corporate and Financial Services, presented a Request for Decision on the 2025 Operating Budget Amendment Proposal. The Request for Decision proposed an increase of \$2,114,400.00 to the 2025 Operating Budget for changes in salaries and benefits.

Alternate Deputy Mayor Flaherty inquired about the number of staff positions that would receive an increase based on the Collective Bargaining Agreement.

Mr. Tumilty was unable to provide the exact number of positions but advised that a full staffing complement was between 160 and 200 employees, depending on the number of casual employees. Mr. Tumilty explained that there would be a seven percent increase for all unionized and excluded positions, and a two percent increase for the senior executive positions. He noted that the increase in benefits was based on years of service and would affect fewer employees.

# d) Request for Decision – Appointment of Chair, Vice Chair and Members for the Governance and Priorities Committee

Steve England, Chief Administrative Officer, presented a Request for Decision for the Appointment of Chair, Vice Chair and Members for the Governance and Priorities Committee.

Deputy Mayor Smith nominated Councillor Stevenson as Chair of the Governance and Priorities Committee. She also indicated that she was interested in serving on the committee.

Councillor Stevenson accepted the nomination.

Alternate Deputy Mayor Flaherty commented that there were two councillors absent, and he wanted to know if they were interested in serving on the committee. He suggested that the committee appointments be deferred.

Mr. England advised that deferring the committee appointments was a decision of Council.

Councillor Sheppard pointed out that the committee appointments had already been deferred, and councillors have had the opportunity to indicate their interest.
