a) Request for Decision – Arnaitok Arena Improvements – Englobe Service Contract 428 Change Order #02

Sumon Ghosh, Director of Engineering and Capital Planning, presented a Request for Decision for a change order to the Englobe Service Contract 428. He advised that Englobe was issued a contract in 2022 for design, contract administration and site inspection services for improvements to the Arnaitok Arena (Zone 1). Mr. Ghosh explained that when the tender was called to complete the work, the cost exceeded the

budget amount. A change order was issued to remove the contract administration and site inspection services until 2023.

Mr. Ghosh advised that the Capital Spending Plan included money to carry out the Arnaitok Arena improvements, therefore a change order was being requested in the amount of \$23,669.60.

b) Federation of Canadian Municipalities (FCM) – Annual Conference and Trade Show 2023 – Toronto – May 25 to May 28, 2023 – Verbal

Rod Mugford, Acting Chief Administrative Officer, advised that the Federation of Canadian Municipalities (FCM) Annual Conference and Trade Show would be held in Toronto from May 25 to May 28, 2023. He noted that in the past, the mayor and two councillors attended the conference.

Mr. Mugford explained that previously, the cost for the mayor to attend the FCM conference was paid for by the Nunavut Association of Municipalities (NAM) as the mayor was the president. This year, however, Mayor Awa is not the NAM president.

Mr. Mugford advised that the City can send the mayor and one councillor and the following costs would be covered:

- Travel
- One study tour workshop
- One tour
- One gala ticket

Mr. Mugford pointed out that the Chief Administrative Officer has the ability to attend the conference and advised that the budget allocation could be used for another councillor to attend.

Mr. Mugford further advised that if a councillor commits to attending the FCM conference and later has to withdraw, the City does not have the budgetary requirements to cover the additional costs for travel changes, and the City would lose the FCM conference spot and the flight reservations. He noted that attendance and travel time to attend the conference would be May 23 to May 30.

Councillors spoke about the value in attending the FCM conference and the importance of the Chief Administrative Officer attending.

Mr. Mugford clarified that a decision was required tonight as to who would be attending the FCM conference, as the arrangements would need to be made by mid-February, and once the bookings have been completed, no changes could be made.

Deputy Mayor Sheppard asked if the budget could be amended so that two councillors could attend the conference. He pointed out that it was not yet known when a Chief Administrative Officer would be hired and suggested that another councillor could attend the FCM conference.
