BY-LAW # 638

AMENDMENT TO TRAFFIC, PARKING AND WALKWAYS BY-LAW

BEING A BY-LAW of the City of Iqaluit, a Municipal Corporation in Nunavut to Amend By-law # 625 which provides for the regulation of traffic in the City and the parking of vehicles on municipal roads;

AND WHEREAS the Cities, Towns and Villages Act, R.S.N.W.T. 1988, c.-8, as amended by S.Nu.2003, c.2, s.70 provides for the passage of by-laws to designate parts of municipal roads as sidewalks, curbs, medians and other component parts;

NOW THEREFORE PURSUANT to the provisions of the Cities, Towns and Villages Act, R.S.N.W.T. 1988, c.-8, as amended by S.Nu.2003, c.2, s.69 and 70, the Council of the Municipality of Iqaluit, NU, in regular session duly assembled, enacts as follows:

SEVERABILITY

If any provision of this by-law is declared invalid because of any word, phrase, clause, sentence, paragraph or section of this by-law or any documents which form part of this by-law or an application thereof to any person or circumstance is declared invalid, the remaining provisions shall not be affected thereby, but shall remain in force.

SECTION 1 - SHORT TITLE

This By-Law may be cited as an "Amendment to the Traffic, Parking and Walkways By-Law".

SECTION 2 – PARKING

By-law #625, Traffic, Parking and Walkways By-law is amended by adding the following sections:

- 3.7 The parking area adjacent to the Post Office shall only be accessible from Queen Elizabeth Way and shall be designated as the "Entrance" and vehicles leaving the parking area shall use Mattaaq Street which shall be designated as the "Exit".

4.2 Designated areas for Taxi stalls shall be identified by signage for passenger pickup, drop off or waiting for fares while on duty. At no time shall taxi drivers leave their vehicles unattended in the designated taxi stalls.

Schedule "C" of By-law #625 shall be amended to provide a fine for violation of 3.7 as follows:



3.7	Failure to Enter or Exit the designated parking area according to the direction indicated.	\$75.00
4.2	Unauthorized parking in taxi area Leaving vehicle unattended in taxi area	\$50.00
5.1	Failure to yield right of way to pedestrian within a crosswalk	\$75.00
5.6	Failure to walk on Walkways	\$25.00
5.9	Operating a vehicle on Walkway or City Trail	\$150.00
5.10	Operating a bicycle on Walkways	\$50.00

EFFECTIVE DATE

This By-Law amendment shall come into full effect upon Third and Final reading.

FINES

Section		Fine
3.1	No driver shall park his or her vehicle on a roadway where it is practicable to park the vehicle off the roadway, unless there is a traffic signage authorizing the parking of the vehicle on that roadway.	\$75.00
3.2	No driver shall park his or her vehicle on a roadway so as to obstruct the passage of vehicles on the roadway.	\$75.00
3.3 (A-K)	Unauthorized parking	\$75.00
3.6	Failure to park in designated parking area or designated parking stall	\$75.00
3.7	Failure to Enter or Exit the designated parking area according to the direction indicated.	\$75.00
4.2	Unauthorized parking in taxi area Leaving vehicle unattended in taxi area	\$75.00
5.1	Failure to yield right of way to pedestrian within a crosswalk	\$75.00
5.6	Failure to walk on Walkways	\$25.00
5.9	Operating a vehicle on Walkway or City Trail	\$500.00
5.10	Operating a bicycle on Walkway	\$50.00
