ADDENDUM #5 – MAY 8, 2019

Q: Can we bid on an alternative unit volume of Ford Specialty Orange Coolant? 5L jugs of the coolant has proven difficult to find.

A: We will accept bids with an alternative unit volume for this item, provided that the total volume is the same or greater than the amount originally requested (125L), but not more than 135L. For example, if 3.78L jugs are quoted, the quantity bid must give a total volume between 125L and 135L (i.e. 34 jugs of 3.78L = 128.52L is acceptable). The bidder must ensure that this line of the cost submission form is clearly amended to indicate the alternative quantity and unit of measure offered.
