**BY-LAW #835  
AMENDMENT TO GENERAL PLAN BY-LAW #703**

---

**A By-law of the City of Iqaluit in Nunavut to amend By-law No. 703, The City of Iqaluit General Plan, pursuant to the Planning Act, R. S. N. (1988), c. P-7, s. 29**

**WHEREAS** the Council of the Corporation of the City of Iqaluit has adopted a General Plan (By-law No. 703), in accordance with the *Planning Act*, and

**WHEREAS** Council wishes to amend the General Plan to permit new residential development along an extended Joamie Court,

**NOW THEREFORE** the Council of the City of Iqaluit enacts as follows:

1. Schedule A of this By-law is declared to form part of General By-law No. 703.
2. Lot 824, Plan 2104, as shown on Schedule A of this By-law, is hereby re-designated from *Institutional* to *Residential Community*.
3. A portion of Lot 823, Plan 2104, as shown on Schedule A of this By-law, is hereby re-designated from 'Open Space' to 'Residential Community'.
4. A new road segment, as shown on Schedule <sup>1C</sup> B of this By-law, is hereby designated a 'Local Road' AD.
5. Figure B of By-law No.703 containing the Populated Area Land Use is hereby amended as shown on Schedule A of this by-law.
6. Figure C of By-law No.703 containing the Walking and Snowmobile Trails is hereby amended as shown on Schedule B of this by-law.
7. Figure D of By-law No.703 containing the Primary Road Network is hereby amended as shown on Schedule C of this by-law.
8. This by-law shall come into effect on the date of its third reading.

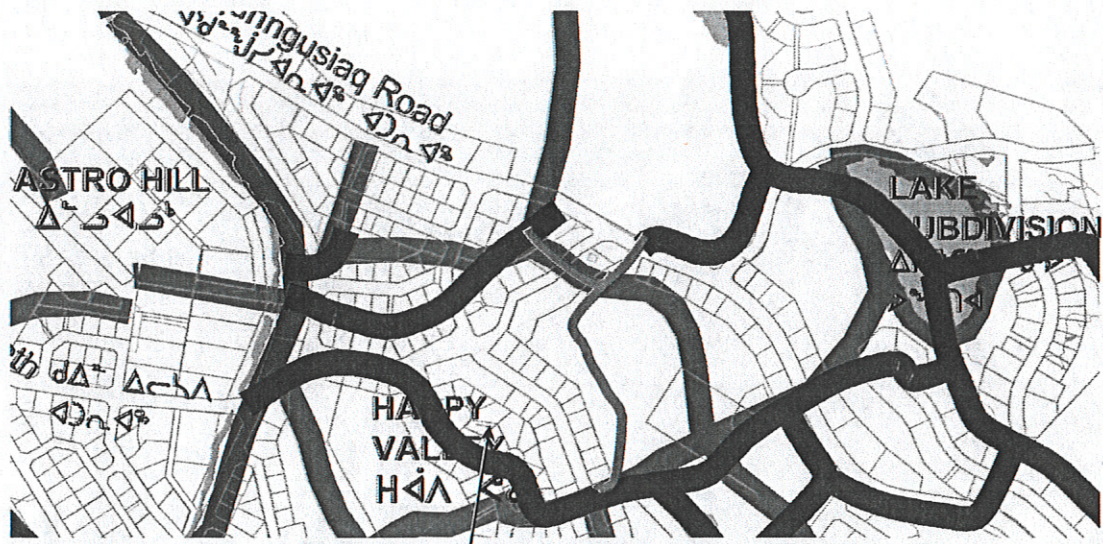
# SCHEDULE A



Change land use designation from *Open Space* to *Residential Community*.

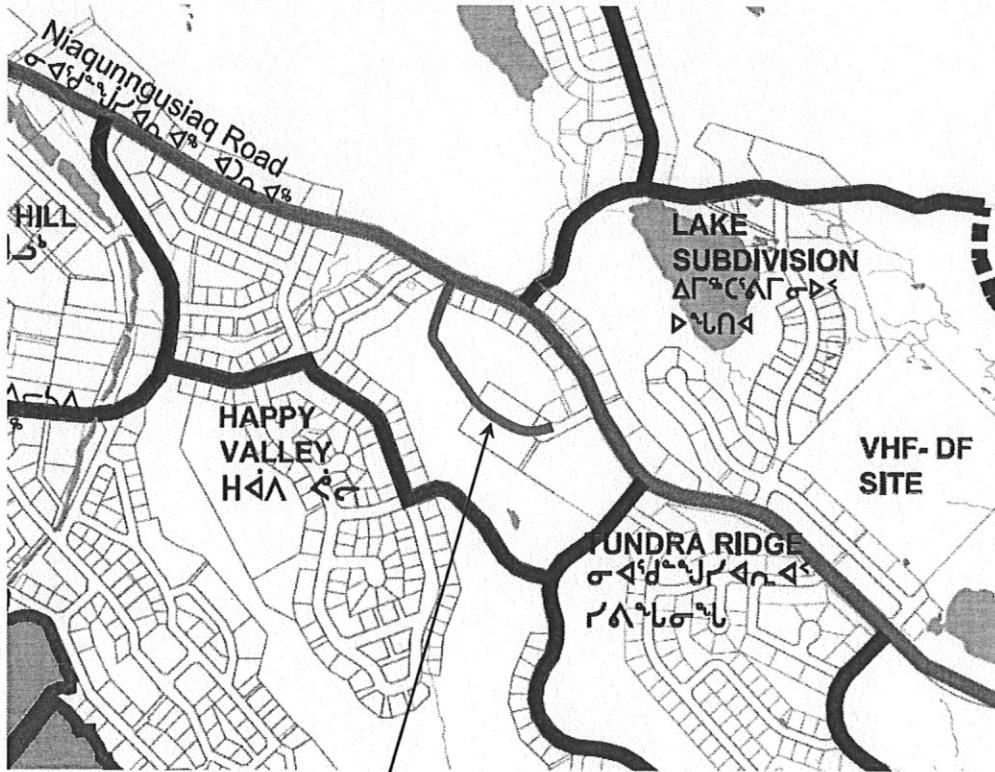
Change land use designation from *Institutional* to *Residential Community*.
