APPOINTMENT OF MUNICIPAL ENFORCEMENT OFFICERS

Amendment of By-law No. 880

A By-Law of the Municipal Corporation of the City of Iqaluit in Nunavut to provide for the appointment of Municipal Enforcement Officers;

PURSUANT to Section 171 of the *Cities, Towns and Villages Act*, S.Nu.2003, c. 2 provides authority to appoint Municipal Enforcement Officers within the boundaries of the City of Iqaluit;

WHEREAS the Council of the Municipal Corporation of the City of Iqaluit deems it desirable to appoint Municipal Enforcement Officers for the enforcement of Municipal By-Laws in the City of Iqaluit;

NOW THEREFORE, the Council of the Municipal Corporation of the City of Iqaluit, in regular session, duly assembled, enacts as follows:

SEVERABILITY

If any provision of the by-law is declared invalid because of any word, phrase, clause, sentence, paragraph or section of this by-law or any documents which may form part of this by-law or an application thereof to any person or circumstance is declared invalid, the remaining provisions shall not be affected thereby but shall remain in force.

SECTION 1 - SHORT TITLE

This By-law may be cited as the "Appointment of Municipal Enforcement Officers By-Law",

SECTION 2 – INTERPRETATION

In this By-Law the following terms (unless the context specifically requires otherwise) shall have the following meanings:

1. "City" means the Municipal Corporation of the City of Iqaluit
2. "Council" means Council of the City of Iqaluit
3. "Municipal Enforcement Officer" means a person appointed in accordance with the *Cities, Towns, and Villages Act* as a Municipal Enforcement

Officer to enforce the by-laws of the City of Iqaluit and any Peace Officer who is entitled by law to enforce the by-laws of the City of Iqaluit.

SECTION 3 – APPLICATION

1. That Municipal Enforcement Services of the City of Iqaluit, NU shall consist of the necessary number of Municipal Enforcement Officers as approved by Mayor and Council.
2. That the persons named in Schedule “A” attached to and forming part of this by-law, are hereby authorized.
3. That Municipal Enforcement Officers so appointed shall carry out the duties specified in Section 172 of the *Cities, Towns, and Villages Act*, S.Nu.2003, c2.
4. That the term of appointment shall expire upon termination of employment with the city as a Municipal Enforcement Officer.

SECTION 4 – OATH & MISSION

1. That every Municipal Enforcement Officer shall, before commencing the duties of office, make and subscribe to an oath or affirmation in the following form before council;

“I _____, do solemnly swear/affirm that I shall, without fear, favour or partiality, and in good conscience with all loyalty to the City of Iqaluit_Nunavut, discharge my proper duty, neither seeking nor accepting direction therein save as provided by law, in all matters and at all times conduct myself accordingly, in the office of Municipal Enforcement”.
2. That the City of Iqaluit Municipal Enforcement Services will be dedicated in serving the community as follows:

“To educate the multi cultural community with professionally trained officers, while enforcing the City’s By-Laws and select Acts to maintain safety within the community through multi agency communications, while serving the community.”

SECTION 5 – REPEAL

That By-Law 880 is hereby repealed.


SECTION 6 - EFFECTIVE DATE
