

THE MUNICIPAL CORPORATION OF THE CITY OF IQALUIT, NUNAVUT
BY-LAW No. 969

SPENDING AUTHORITY
BY-LAW

A By-law of the Municipality of Iqaluit in Nunavut to appoint officer(s), other than the Chief Administrative Officer, and to establish the powers and duties of the officer(s) pursuant to section 44 of Cities, Towns and Villages Act of Nunavut, the R.S.N.W.T. 1988, c. C-8;

AND WHEREAS the Cities, Towns and Villages Act provides that the municipal council may, by by-law, appoint employees to be officers and authorize them to perform any statutory duty assigned to the Chief Administrative Officer other than those assigned under section 47; or, any other duties the council considers necessary;

NOW THEREFORE, the Council of the Municipal Corporation of the City of Iqaluit, in regular session duly assembled, enacts as follows:

1. Provides for the spending authority and limit of municipal personnel.
2. Shall come into force upon Third and Final Reading.

1. SEVERABILITY

If any provision of this by-law is declared invalid because of any work, phrase, clause, sentence, paragraph or section of this by-law or any documents, which form part of this by-law or an application thereof to any person, or circumstance is declared invalid, the remaining provisions shall not be affected thereby, but shall remain in force.

2. INTERPRETATION

1. In this by-law:

- (a) "Act" means the Cities, Towns and Villages Act of Nunavut;
- (b) "City" means the City of Iqaluit in Nunavut;
- (c) "Council" means the Council of the Municipality of Iqaluit;
- (d) "Chief Administrative Officer" means the Chief Administrative Officer of the City of Iqaluit;
- (e) "Officer" means the person(s) appointed to hold the position(s) named in Schedule "A" of this by-law.
- (f) "schedule" means a schedule attached to and forms part of this by-law.

3. APPOINTMENT

1. (a) The individual holding the position named in Schedule "A" is hereby appointed as an officer and has authority to sign negotiable instruments on behalf of the City of Iqaluit as referenced in section 141 of the Act.


4. GENERAL PROVISIONS

1. Any amount over \$500,000.00 shall require both the Chief Administrative Officer signature and co/signature of Mayor, or in the Mayor's absence the Acting Mayor.
2. When signing a loan, the Chief Administrative Officer signature shall be accompanied by a secondary signatory authority, either the Mayor, or in the Mayor's absence the Acting Mayor.
3. The attached Schedule "A" may be amended and updated from time to time as required by Resolution of Council and not require a by-law amendment.
