BY-LAW # 992

AMENDMENT TO GENERAL PLAN BY-LAW # 898

A By-law of the City of Iqaluit in Nunavut to amend By-law No. 898, The City of Iqaluit General Plan, pursuant to the Planning Act, R. S. N. (1988), c. P-7, s. 29.

WHEREAS the Council of the Corporation of the City of Iqaluit has adopted a General Plan (By-law No. 898), in accordance with the *Planning Act*, and

WHEREAS Council wishes to amend the General Plan to allow development to occur on the untitled Municipal Lands located north of the Parcel E Inuit Owned Lands along Sivumugiaq Street;

NOW THEREFORE the Council of the City of Iqaluit enacts as follows:

1. Schedules A, B and C are declared to form part of this By-law.
2. Section 5.10 of the General Plan, being all policies for the *Federal Road Special Policy Overlay*, is hereby deleted.
3. Annex B of the General Plan, being the *Inuit Owned Land Parcel E Development Scheme*, is hereby deleted, and the Annexes re-lettered accordingly.
4. The *Federal Road Special Policy Overlay* is hereby removed from Figure B of the General Plan, as shown on Schedule A of this By-law.
5. The untitled municipal lands, as shown on Schedule A of this By-law, are hereby redesignated from *Open Spaces* to *Core Area*.
6. Figure B containing the Populated Area Land Use map is hereby amended as shown on Schedule A of this by-law.
7. Figure C containing the Walking and Snowmobile Trails map is hereby amended as shown on Schedule B of this by-law.
8. Figure E containing the Piped Municipal Services map is hereby amended as shown on Schedule C of this by-law.
9. This by-law shall come into effect on the date of its third reading.



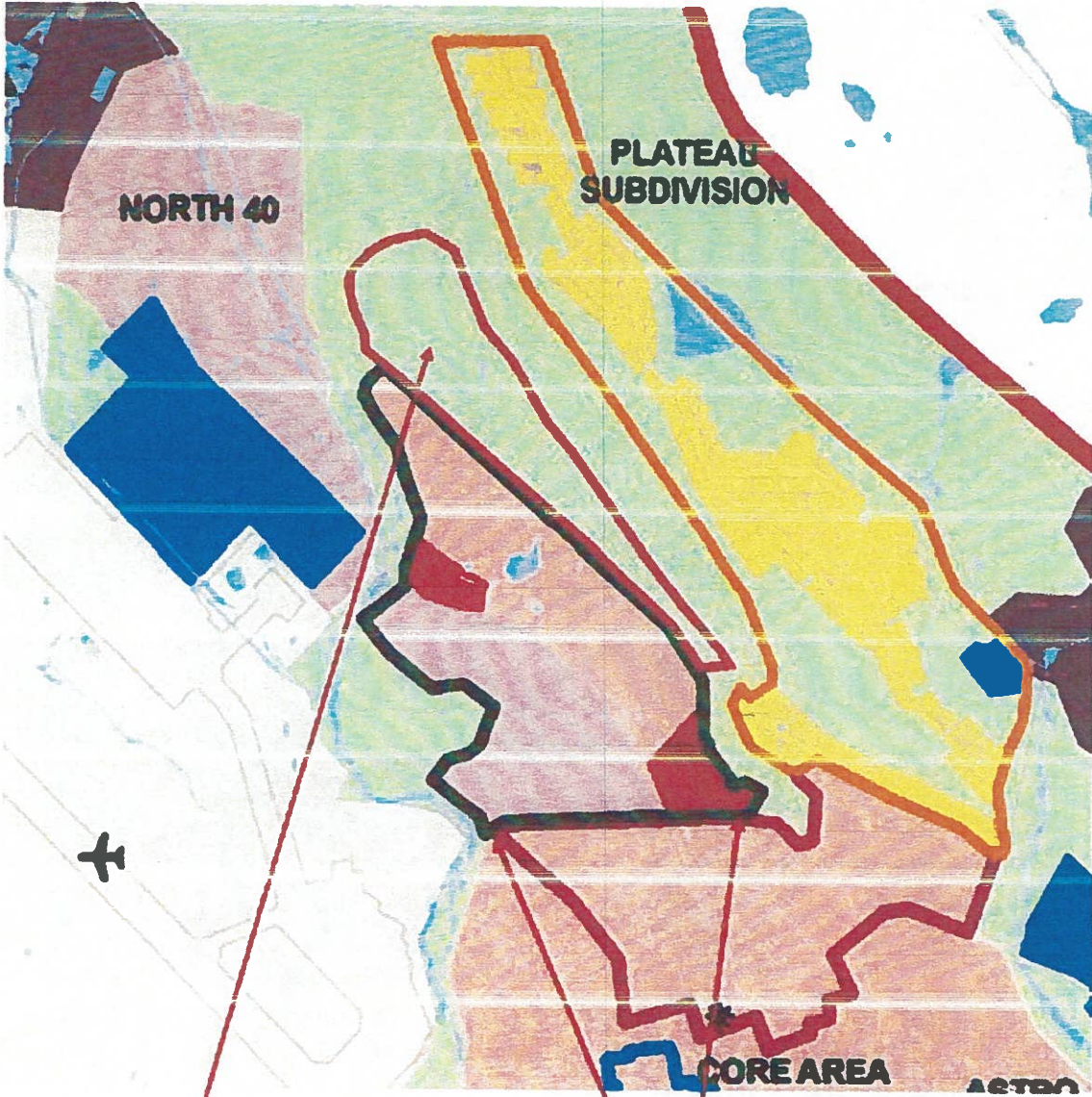

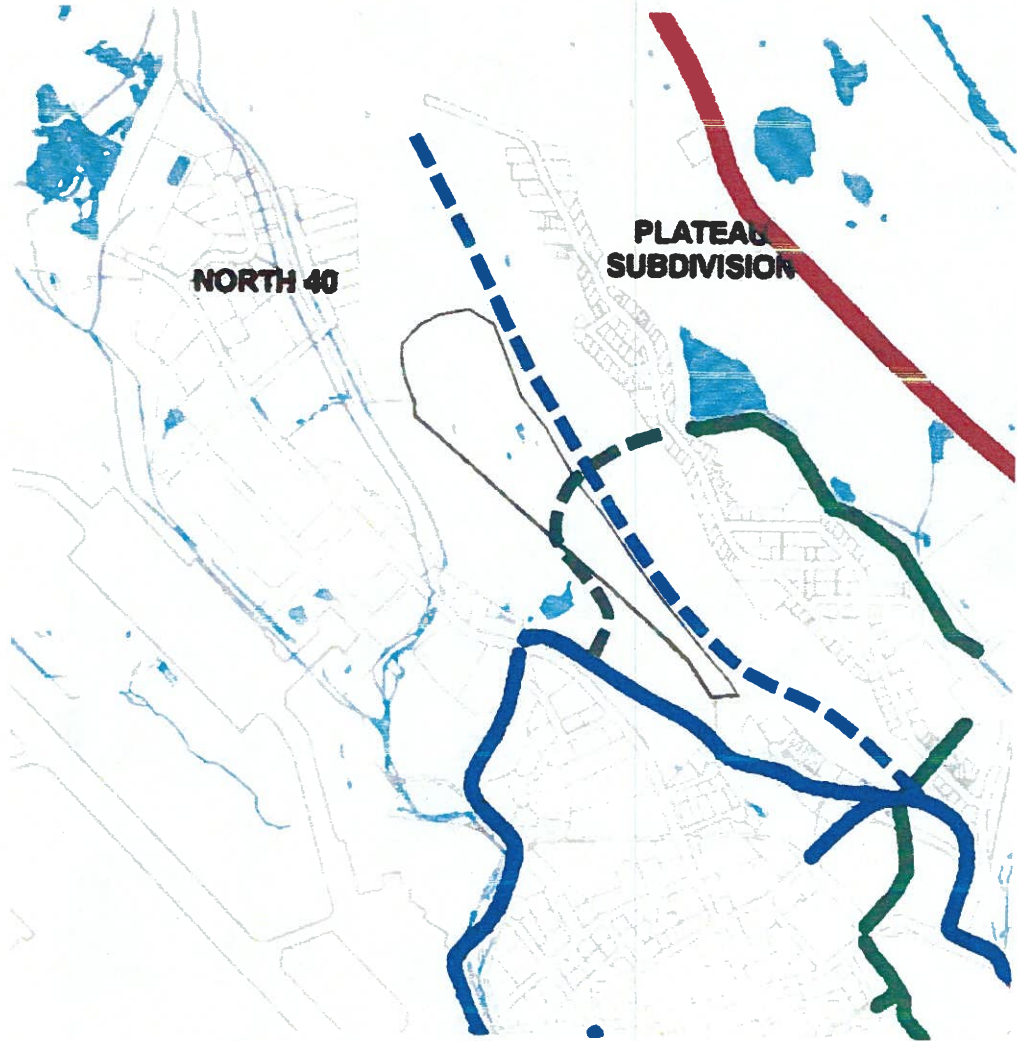
