

THE MUNICIPAL CORPORATION OF THE CITY OF IQALUIT, NUNAVUT
BY-LAW No. 984
CANNABIS CONSUMPTION TOBACCO USE AND VAPING AMENDMENT
BY-LAW

A By-law of the Municipal Corporation of the City of Iqaluit to regulate public consumption of cannabis, Tobacco, smoking and vaping in the City of Iqaluit.

WHEREAS the Cities, Towns and Villages Act R.S.N.W.T. 1988,c-8,s.54.2 subject to limitations on its powers in this or any other enactment, a council may pass by-laws for municipal purposes respecting the following matters (a) the safety, health and welfare of people and the protection of people and property, (b) people, activities and things in, or near a public place or place that is open to the public.

WHEREAS Council wishes to amend the Cannabis Consumption Tobacco Use and Vaping By-law 863.

NOW THEREFORE, the Council of the Municipal Corporation of the City of Iqaluit, in a regular session, duly assembled, enacts as follows:

1. Repeals and strikes out subsections 5.03 of Article 5 of by-law 863 – Exceptions. Despite any other provision of this By-law, a person may, inside an enclosed premise where the primary function of the premises is the sale of electronic cigarettes, use an electronic cigarette to sample a product, other than tobacco or cannabis, prior to purchase.

2. Repeals and strikes out subsection 5.04 of Article 5 of by-law 863 - Exceptions. Section 404 does not apply to an employer, operator or proprietor who allows a person to use an electronic cigarette to sample a product, other than tobacco or cannabis, prior to the purchase inside an enclosed premise where the primary function of the premises is the sale of electronic cigarettes.
3. All remaining sections and subsections of By-law 863 remain valid and in force.

1. SHORT TITLE

This By-law may be cited as the Cannabis Consumption Tobacco Use and Vaping Amendment by-law 984.

2. DEFINITIONS

“CAO” means Chief Administrative Officer.

“City of Iqaluit” means the municipal corporation of Iqaluit.

“Council” means the council of the City of Iqaluit.


3. EFFECTIVE DATE

This By-law shall come into force upon receiving third and final reading.
