 - o 40 passes for a week for guest artists to access facilities, such as the Aquatic Centre
 - O Use of the pool to hold a Children's Pool Party Concert with Drum Dancing on June 21 from 9:00 a.m. to 12 noon
 - O Use of the Elders' Qammaq for Drum Dance sharing and workshops from June 18 to 23 from 9:00 a.m. to 5:00 p.m.
 - Ten traditional drummers
 - Collaborating with the Elders' Society regarding the workshop
