Administration explained that the purpose of the Public Hearing is so that Development Scheme known as the "Future Development Area B Development Scheme" attached to the by-law as Schedule A be adopted by Council. Schedule A of the by-law is declared to form part of the General Plan By-law No. 703, to be attached and annexed as "Annex C – Future Development Area B Development Scheme". "Figure B – Populated Area Land Use" of General Plan By-law No. 703 is amended by replacing the "Future Development Area" policy designation with the "Residential Community" policy designation with a "Development Scheme Overlay" as illustrated on Schedule B of the Future

Development Area General Plan and Development Scheme By-law Amendment No. 784. "Figure C – Walking and Snowmobile Trails" of General Plan By-law No. 703 is amended by deleting a portion of the "Snowmobile Trail" corridor designation, as illustrated on Schedule 'C' of this By-law. "Figure D – Primary Road Network" of General Plan By-law No. 703 is amended by deleting the "Proposed Collector Road" indicated over the area subject to the Development Scheme and extending the "Collector Road" designation along Road to Nowhere, as illustrated on Schedule 'D' of this Bylaw.
